BASF 2025 Surtain Launch Offer Terms and Conditions

- Offer Overview:** Subject to these terms, conditions and restrictions set forth below (the “**Terms**”), BASF Canada Inc. (“**BASF**”) is offering each Eligible Participant (as defined below in Section 3) the opportunity to receive one (1) NOCO GENIUS5 battery charger with an approximate retail value of \$120 CAD (the “**Reward**”), by making an eligible purchase of **Surtain™ Herbicide**, Qualifying Product (as defined below in Section 4) during the Offer Period.
- Offer Period:** The 2025 Surtain Launch Offer (the “**Offer**”) is administered by BASF and begins on October 1, 2024 at 7:00 a.m. Eastern Time (“**ET**”) and ends on September 30, 2025 at 11:59 p.m. ET (the “**Offer Period**”).
- Eligibility:** The Offer is open to Canadian growers who: (i) reside in Ontario, Quebec, New Brunswick, Nova Scotia or Prince Edward Island; (ii) are the owner, operator or designated representative of a farm (a “**Farm**”); (iii) have signed and returned BASF’s form of PIPEDA consent, permitting BASF to obtain relevant customer transactional Data (defined below) from authorized Canadian BASF retailers; and (iv) have reached the legal age of majority in their province of residence (each, an “**Eligible Participant**”). BASF employees, agents, contractors and those residing with them (whether related or not) are not eligible to participate in this Offer. These Terms govern this Offer and must be followed by all Eligible Participants at all times. By agreeing to participate in the Offer, each Eligible Participant is signifying his/her agreement to comply with, and be legally bound by, these Terms. This Offer is not available to buying groups, relationship groups (including but not limited to any BASF reward group) or any individual or entity other than an Eligible Participant as defined above.
- How to Qualify:** To qualify for the Offer and be eligible to receive a Reward, an Eligible Participant must:
 - Comply with all of the terms and conditions set forth in these Terms (as determined by BASF in its sole and absolute discretion); and

For information on the price of the Qualifying Product listed in these Terms, please contact your authorized Canadian retailer. Purchases of Qualifying Product returned for any reason whatsoever and Qualifying Product purchased for resale are not eligible for a Reward and do not qualify in the Offer. Qualifying Product must be purchased from a BASF authorized retailer (product purchased from a retailer that is not a BASF authorized retailer does not qualify as a Qualifying Product). Offer eligibility is subject to receipt of verified retailer Data (as defined in Section 7 below). UNDER NO CIRCUMSTANCES WHATSOEVER WILL ANY DIFFERENCE BETWEEN THE ACTUAL RETAIL PRICE OF A REWARD AS AT THE TIME OF REWARD FULFILLMENT AND THE VALUE OF THE REWARD NOTED ABOVE BE AWARDED.

- Verification:** BASF reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to BASF): (i) for the purposes of verifying an Eligible Participant’s eligibility to participate in this Offer; (ii) for the purposes of verifying the legitimacy of any Data (as defined below in Section 8), Qualifying Products, purchase transaction(s) and/or other information; and/or (iii) for any other reason BASF deems necessary, in its sole and absolute discretion, for the purposes of administering this Offer in accordance with the letter and spirit of these Terms. Failure to provide such proof to the complete satisfaction of BASF within the timeline specified by BASF may result in disqualification in the sole and absolute discretion of BASF. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Terms shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.

To the fullest extent permitted by applicable law, all issues and questions concerning the construction, validity, interpretation and enforceability of these Terms or the rights and obligations of Eligible Participants, BASF or any of the other the Released Parties in connection with the Offer will be governed by and construed in accordance with the domestic laws of the Province of Ontario and the federal laws of Canada applicable therein, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. The parties hereby consent to the exclusive jurisdiction and venue of the courts located in Ontario in any action to enforce (or otherwise relating to) these Terms or relating to this Offer.
