Advice for fire-fighters

Protective equipment for fire-fighting:

Firefighters should be equipped with self-contained breathing apparatus and turn-out gear.

Further information:

Collect contaminated extinguishing water separately, do not allow to reach sewage or effluent systems. 6. Accidental release measures

Further accidental release measures:

Dust in sufficient concentration can result in an explosive mixture in air. Handle to minimize dusting and eliminate open flame and other sources of ignition.

Methods and material for containment and cleaning up

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal.
