Active ingredient

Dimethomorph – Group 40

Formulation

Flowable concentrate

One case contains

2 x 4.5 L jugs

Storage

Store in cool, dry, ventilated area away from food and animal feed.

Crop

Potatoes

Timing

5 to 10 day interval

During periods of rapid growth or high disease pressure, use a shorter interval.

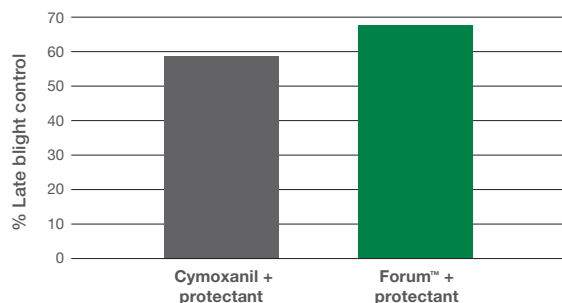

Tuber blight in storage¹ (*Phytophthora infestans*)

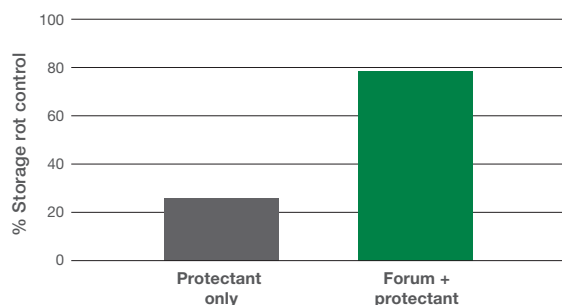

Application rates

One jug of Forum treats 10 ha (25 acres).

Potatoes 450 mL/ha (182 mL/ac)

Mixing order

1. Ensure the spray tank is clean before use.
 2. Fill the tank 1/2 full of water and start agitation.
 3. Add the required amount of Forum fungicide to the tank while agitating.
 4. Continue agitation while filling the remainder of the spray tank.
 5. After use, clean the spray tank according to label precautions.

Application tips

Rainfastness – 2 hours.

Restricted entry interval – 12 hours.

Resistance management – In order to reduce the risk of developing fungicide resistance, Forum fungicide must be used in a tank mix with other fungicides effective against late blight.

Pre-harvest interval

4 days for potatoes.

Tank mixes

Fungicides – Polyram[®] DF, Bravo[®], Dithane[®] DG Rainshield[®]

Always apply Forum as a tank mix with a protectant/contact fungicide such as Polyram DF or Bravo to protect against early blight and for resistance management.
