3. BASF Qualifying Reward Products for the Program, to determine eligibility to receive an InVigor Reward, Baseline Reward and Elite Reward, include all BASF Products listed in Term 2 above with the exception of the following:
ACROBAT, ALTITUDE FX 3, BASAGRAN, CANTUS, CENTURION, HEADLINE, LIBERTY 150 SN, LANCE, LANCE AG, PRIAXOR DS, INVIGOR HYBRID CANOLA and SEFINA.
4. In order for Solo brands to qualify for an InVigor Reward, Baseline Reward and/or the Elite Reward, the Eligible Participant must register a minimum of three hundred (300) acres of **Clearfield®** lentils with a BASF **AgSolutions** Grower Representative, through **AgSolutions** Customer Care, or a Western Canadian retailer.
5. In order to be eligible for an InVigor Reward, first you must purchase a minimum of 300 acres of InVigor hybrid canola and a minimum 300 acres of Liberty 150 SN herbicide. Second, you must then meet the minimum ratio of one (1) Liberty 150 SN herbicide acre for every two (2) InVigor acres purchased (1:2 ratio) above the minimum of 300 acres of Liberty 150 SN herbicide. For example, if you purchase 700 acres of InVigor, you'll need to purchase a minimum of 350 acres of Liberty 150 SN herbicide. And if you purchase 500 acres of InVigor, you'll need to purchase a minimum of 300 acres of Liberty 150 SN herbicide since it is a minimum requirement to be eligible for the reward.
6. In order to be eligible for a Baseline Reward, first you must purchase \$20,000 CAD or more of qualifying BASF Product from an authorized Western Canadian retailer. Second, you must purchase a minimum of three hundred (300) acres of BASF Qualifying Reward Products from any two (2) or more of the four (4) BASF Segments set out in the table above. For the avoidance of doubt, purchases of BASF Qualifying Reward Products for the purpose of fulfilling the latter requirement will also count towards fulfilling the requirement to purchase \$20,000 CAD or more of qualifying BASF Product. Purchases of the Lance brands will be taken into account in the fulfillment of the three hundred (300) acre minimum purchase threshold for Segment 3; however, the Lance brands are not Qualifying Reward Products in which the Eligible Participant will receive a Baseline Reward.
7. In order to be eligible for a Liberty Reward of \$1 per acre on Liberty 150 SN, first you must purchase a minimum of 300 acres of InVigor hybrid canola and a minimum of 300 acres of Liberty 150 SN herbicide. Second, you must achieve a minimum ratio of one (1) Liberty 150 SN herbicide acre for every one (1) InVigor acre (1:1 ratio) above the minimum of 300 acres of Liberty 150 SN herbicide. You may earn an additional \$1/acre (amounting to a total of \$2/acre) if you qualify for a Liberty Reward and a Baseline Reward. For example, if you purchase 1000 acres of Liberty 150 SN herbicide and 500 acres of InVigor hybrid canola, and also qualify for a Baseline Reward, you will be entitled to the maximum reward of \$2 per acre on 1000 acres of Liberty 150 and would receive \$2000.
8. In order to be eligible for the BASF Spud Protector Reward, you must purchase a minimum of 120 acres of Titan AND 120 acres of Veltyma fungicide, Cimegra insecticide or Zidua SC herbicide or any combination of Veltyma, Cimegra or Zidua SC so long as there is a total of 120 acres combined.
